The NALC has negotiated a tentative agreement with the USPS. The proposed agreement was reached on October 17, 2024.

Under Article 16 of the NALC Constitution, agreements require ratification through a mail referendum by eligible members, with approval determined by a majority of valid ballots returned. If accepted, the agreement takes immediate effect. If rejected, the Postal Reorganization Act allows continued negotiations or referral to an interest arbitration board, whose decisions are final and binding.
